particular the subject of residence hall occupancy and the potential for new residence halls, and she also addressed Greek life and housing.

REPORT OF THE UNIVERSITY ADVANCEMENT COMMITTEE

Chair McNair reported that no action items were considered by the committee. They received a report on private giving from July 1, 2002 to June 30, 2003. Vice Chancellor Stewart briefed the committee on the feasibility initiative (The Impact of One. The Power of Many.) which will begin with three feasibility luncheons, scheduled for September 2, 15, and 23. The luncheons will provide an opportunity for the Chancellor to convey to our constituencies our vision and our fundraising efforts over the next decade. Charles Witzleben, campaign consultant, will talk to Development staff, the Chancellor, the Provost, and the Deans about their readiness for the campaign. A final presentation of the feasibility study will be shared with the Excellence Foundation at a meeting on February 17, 2004, to which the Trustees will be invited. This will be a very aggressive campaign for UNCG.

CLOSED SESSION

The nonprofit corporation to be created for management of the Joint Millennial Campus will be the entity designated to accept transfer of the Central North Carolina School for the Deaf from the UNC Board of Governors.

The nonprofit corporation to be created for management of the Joint Millennial Campus will be the entity designated to accept transfer of the Central North Carolina School for the Deaf from the UNC Board of Governors.
